INTENDED USE

This product is intended for in vitro diagnostic use in the calibration of CRP on clinical chemistry systems.

SAFETY PRECAUTIONS AND WARNINGS

The calibrator contains human CRP in a stabilised protein matrix. Human source material, from which the product has been derived, has been tested at donor level for the Human Immunodeficiency Virus (HIV I, HIV 2) antibody, Hepatitis B Surface Antigen (HbsAg), Hepatitis C Virus (HCV) antibody, HBV DNA, HCV RNA and HIV DNA and found to be NON-REACTIVE. FDA approved methods have been used to conduct these tests.

However, since no method can offer complete assurance as to the absence of infectious agents, this material and all patient samples should be handled as though capable of transmitting infectious diseases and disposed of accordingly.

For in vitro diagnostic use only, do not pipette by mouth, exercise the normal precautions required for handling laboratory reagents.

This material contains Sodium Azide. Avoid ingestion or contact with skin or mucous membranes. In case of skin contact, flush affected area with copious amounts of water. In case of contact with eyes or if ingested, seek immediate medical attention.

Sodium Azide reacts with lead and copper plumbing, to form potentially explosive azides. When disposing of such reagents, flush with large volumes of water to prevent azide build up. Exposed metal surfaces should be cleaned with 10% sodium hydroxide.

Dispose of this material according to local regulations.

STORAGE AND STABILITY

Unopened: The hsCRP Calibrator Series is supplied ready for use and is stable up to the expiry date, when capped and stored at $+2^{\circ}$ C to $+8^{\circ}$ C in the absence of contamination.

Opened: Once opened, the hsCRP Calibrator Series is stable for 30 days when stored at $+2^{\circ}$ C to $+8^{\circ}$ C in the absence of contamination. Only the required amount of product should be removed and the cap subsequently replaced. After use, any residual product should NOT BE RETURNED to the original vial.
